By entering the Sunrise '12 Days of Christmas' Competition, you are agreeing to the following terms and conditions:

**1. STANDARD TERMS**

1.1 Information on how to enter forms part of the terms and conditions of entry.

**2. WHO CAN ENTER?**

2.1 Subject to clause 2.2, entry is open to residents of Australia, 18 years of age or older, where the Channel Seven signal is received.

2.2 Employees and their immediate families of Seven Network (Operations) Ltd, Ansible Pty Ltd, Sponsors listed in clause 7.2, and their associated agencies (and related body corporates as defined under the Corporations Act 2001 (Cth)) and companies associated with this promotion are not eligible to enter.

- 3.2 In order to enter, viewers must watch Sunrise (Monday to Friday) & Weekend Sunrise (Saturday & Sunday) (“the Program”) on the Seven Network during the Competition Period where there will be a competition segment aired during the Program (or any replacement program broadcast in the Sunrise timeslot) which will invite viewers to enter the competition and disclose a code word each day.
- 3.3 In order to enter, viewers must:
