TERMS AND CONDITIONS

By entering the Sunrise 'Amazon Christmas Wish List', you are agreeing to the following terms and conditions:

1. STANDARD TERMS

1.1 Information on how to enter forms part of the terms of entry.

2. WHO CAN ENTER?

2.1 Subject to clause 2.2, entry is open to all residents of Australia aged 18 years and older, where the Channel Seven and affiliate broadcasting signals are received.

2.2 Employees and their immediate families of Seven Network (Operations) Limited, Ansible Pty Ltd, Amazon Australia and their associated agencies and companies are not eligible to enter.

3. HOW TO ENTER


3.1 The competition commences on **Wednesday 5 December 2018 at 05:30 AM (AEDT)** and concludes on **Tuesday 11 December 2018 at 04:30 PM (AEDT)** ("the Competition Period") however, the eligible entry period for each daily prize will commence and conclude on the following dates and times:

3.2 In order to enter, viewers must watch Sunrise (Monday to Friday) ("the Program") on the Seven Network during the Competition Period.
