

TERMS AND CONDITIONS for KISS x Three Mobile Breakfast Promotion May (the “Competition”).

Where there is any conflict between these Specific Terms and the General Terms, the Specific Terms shall prevail.

1. THE ON AIR COMPETITION AND HOW TO WIN

<p>1.ENTRY ROUTES AND COSTS</p>	<p><u>Entry to the Competition is available via the following routes:</u></p> <p>(A) Via WhatsApp. Entrants will send a WhatsApp voice note to 03330 916 974.</p> <p>Some mobile phone plans may charge for data whilst using WhatsApp.</p> <p>Standard network/data charges may apply.</p> <p>Entries are restricted to one per person per round.</p>
<p>2.COMPETITION MECHANIC AND HOW TO WIN</p>	<p>2.1 Submitting Entries</p> <ul style="list-style-type: none"> • Entrants must submit a voice note to our dedicated WhatsApp line (03330 916 974), explaining their friendship group of four and why they would be a fun group to go to Ibiza during the Entry Period (3.0). • Entrants must also alert their chosen 3 friends that they have entered the competition at time of entry, so they are ready to get in contact with us if their entry is chosen. Only those who can confirm they have contacted their 3 friends are able to proceed with the competition. • In the event of a WhatsApp outage affecting UK users, winner(s) will be selected from entries already submitted during the Entry Period. <p>2.2 Shortlisting Selection</p> <p>All valid entries will be reviewed by a judging panel made up of the Kiss Production Team, the Production Manager and an independent judge. They will select a shortlist of up to 5 entries (minimum of 1, maximum of 5) weekly as set out below. Valid entries will be judged on the following criteria:</p> <ul style="list-style-type: none"> • We’re looking for the funniest and most entertaining stories that stand out on air. KISS brand filter will be applied to all stories. • It must be a personal story. No second-hand or made-up stories are permitted. • Entries must be suitable for broadcast, with no offensive, discriminatory or explicit content. • Entries should be concise (guidance is to aim for under 1 minute). • Entries from each week of the Competition will roll over to the next week, if they are not selected as potential contestant. They can continue to roll over to other weeks as such. • Entries will remain valid throughout the Entry Period unless selected or deemed invalid.

The selected contestant each week from the list of weekly shortlisted entrants will be selected through the judging panel made up of the KISS Production Team, the Production Manager and an independent judge following the judging criteria.

A new shortlist of entrants will be selected each week. One entrant who has entered the Competition via WhatsApp will be selected and contacted by the KISS Breakfast production team on the Friday prior to the competition on the Monday to take part in the on-air Competition Round and will become that week's contestant.

If the selected contestant answers on the Monday, they will be required to nominate a second member of their friendship group. The contestant is responsible for contacting their friend and inviting them to contact KISS Breakfast to participate in the Tuesday Competition Round. Tuesday's participant will have 10 minutes to call KISS Breakfast Production team on 03448 11 22 33 from the point they are instructed to do so by the KISS Breakfast Production Team off-air. KISS cannot contact any nominees directly without their prior consent.

If the second participant answers on the Tuesday, they must nominate a third member of their friendship group. The second participant is responsible for ensuring the nominated individual contacts the KISS Breakfast production team. Wednesday's nominated entrant will have 10 minutes to call KISS Breakfast Production team on 03448 11 22 33 from the point they are instructed to do so by the KISS Breakfast Production Team off-air.

If the third participant answers on the Wednesday, they must nominate a fourth member of their friendship group. The third participant is responsible for ensuring the nominated individual contacts the KISS Breakfast production team to take part in the Thursday Competition Round. Thursday's nominated entrant will have 10 minutes to call KISS Breakfast Production team on 03448 11 22 33 from the point they are instructed to do so by the KISS Breakfast Production Team off-air.

If the fourth participant answers on the Thursday, all four participants will be invited to take part in the final Competition Round on the Friday.

If at any stage a nominated participant declines to take part, cannot be contacted, fails to contact KISS Breakfast in time, or is otherwise unavailable, the current participant may nominate one (1) alternative contestant. The replacement nominee will have a fresh 10-minute window to call KISS Breakfast Production team on 03448 11 22 33 from the point they are instructed to do so by the KISS Breakfast Production Team off-air. Failure of the replacement nominee to make contact within this timeframe may result in disqualification at the discretion of the production team.

At any stage, an incorrect answer, failure to participate, or failure to comply with these Terms and Conditions may result in the group's disqualification and the selection of an alternative entrant or group at the discretion of the production team.

Any entrant or nominated participant who is not selected, does not progress, or whose group is disqualified may be permitted to enter future Competition Rounds, subject to the terms outlined in Section 1.

2.3 The Competition

- The group of four, each day (Monday – Thursday) will come on-air and answer the question. If each day gets the question is answered correctly then the contestant and 3 friends will be required to come on-air on the Friday and answer a simple multiple-choice question. The prize will only be awarded if the friendship group on the Friday get the multiple-choice answer correct.
- The Prize will only be awarded once the group is explicitly confirmed as winners by KISS on-air or by the Production Team.
- There will be a new contestant and 3 friends each week called to air.
